# Philip Usher Constructions (Lawnton Lakes Development) Privacy Policy

## 1. We respect your privacy

**1.1.** Philip Usher Constructions (Lawnton Lakes Development) respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. This policy sets out how we collect and treat your personal information.

## 2. What personal information is collected

**4.4.** If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our user databases, together with any personal information and non-personal information contained in those databases.

## 5. Disclosure of your personal information

**5.1.** Philip Usher Constructions (Lawnton Lakes Development) may disclose your personal information to any of our employees, officers, insurers, professional advisers, agents, suppliers or subcontractors insofar as reasonably necessary for the purposes set out in this privacy policy.

**5.2.** If we do disclose your personal information to a third party, we will protect it in accordance with this privacy policy.

## 6. Security of your personal information

Although we take measures to safeguard against unauthorised disclosures of information, we cannot assure you that personal information that we collect will not be disclosed in a manner that is inconsistent with this Privacy Policy.

## 7.Access to your personal information

**7.1.** You may request details of personal information that we hold about you in accordance with the provisions of the Privacy Act 1988 (Cth).
